RULES AND GUIDELINES

- 1. Ragging in all forms is strictly prohibited at LMF and defaulters will be dealt with as per the directive of the Supreme Court of India.**

4. As per the University norms **minimum 75%** attendance in every semester is compulsory failing which the student may be debarred from appearing in University examination. He will keep the Institute indemnified of the same.
5. All fees and other charges for the semester /session are to be paid as per the Institute policies. Dates of payments will be announced and are to be followed.
6. A student facing any disciplinary action may be fined and / or disallowed to attend classes. He/She will be marked absent for this period. He/ She will bear responsibility of completing the requirements of attendance in such cases.
7. All students are to be in proper college (LMF) **UNIFORM** in the campus failing which they will not be allowed in the campus /classes and will be marked absent at their own risk.
